#### Item 3: Advocacy Workshop

Dr Adano W. Roba, Acting Director-General of the Competition Authority of Kenya, gave an update on the upcoming Advocacy Workshop. The workshop will take place in Nairobi from 22 to 23 February 2024 under the theme of "Bouncing Back: Competition Advocacy and Resilience to Global Shocks". In addition, there will be a pre-event on 21 February organised by the Competition Authority of Kenya in collaboration with the US FTC. The theme of the pre-event will be "Digital Markets Advocacy Workshop: An in-depth discussion of market studies and inquiries".

# Item 4: Working Group Status Reports

The Philippine Competition Commission, in its capacity as Co-Chair of the Advocacy Working Group, reported on the status of the group's projects focusing on the projects "Interactions between Sector Regulators and Competition Authorities", "Evaluating the Effectiveness of Advocacy Initiatives" and "Assessing Progress in the Development of Successful Advocacy Strategies to the Judiciary".

## Item 5: Operational Framework

The Competition Bureau Canada, in its capacity as Co-Chair of the Operational Framework Working Group, informed the SG members about the status of the Operational Framework review. A first conference call took place on 21 December 2023 which covered the issue of SG decision-making. Further group calls will be scheduled, followed by regular updates in SG meetings.

## Item 6: SG Members' Hot Topics Presentation

Nuno Cunha Rodrigues, President of the Portuguese AdC, gave a presentation on "Competition and generative artificial intelligence", a topic on which the Portuguese AdC recently published a paper. The presentation was followed by a lively discussion with interventions by several SG members.
