Project 3. Updating the ICN Recommended Practices with a new Chapter on Counterfactual (Lead by UK CMA).

The analysis of whether a merger is likely to harm competition involves a comparison of the prospects for competition with the merger against the competitive situation without the merger. The latter is called the 'counterfactual'. The counterfactual is an analytical tool used in answering the question of whether the merger may raise competition concerns. In recent years, counterfactual analysis has become increasingly relevant due to the more frequent consideration by national competition authorities of dynamic counterfactual situations, especially in relation to evolving markets.

Whilst the 2006 ICN Merger Guidelines Workbook has a specific section on the counterfactual analysis, there is a notable gap in the ICN Recommended Practices for Merger Analysis, where this topic is not specifically addressed (except in relation to failing firm scenarios).

In light of this, the MWG Co-Chairs intend to add a new chapter on Counterfactual reflecting the latest best practices from national competition authorities.

Project 5. Update of the ICN Recommended Practices Chapter on the Use of Market Shares: Thresholds & Presumptions (led by the French Autorité de la concurrence)

The MWG co-chairs intend to update the chapter on the use of market shares: thresholds and presumptions of the ICN recommended practices for merger analysis, last updated in April 2008.

Markets shares are one of the main indicators used by competition agencies to assess companies' market power. In some jurisdictions, market shares, when reaching a certain level, give rise to a presumption of competitive harm. The update of the concerned chapter aims at assessing the appropriate metrics to evaluate market shares and the relevance of the latter to appreciate companies' market power, in particular in the context of digitalised economies and rapidly evolving markets.

Initial views on the scope of the update might be collected during webinar(s) and, if feasible, during a dedicated session at the MWG workshop in Taiwan in November 2024. No survey or written consultation of members will take place in 2024.

This is a multi-annual project.

Project 6. Update of the ICN Recommended Practices Chapter on The Legal Framework for Competition Merger Analysis (led by the US FTC)

This initial RP Chapter frames the ultimate goal of merger control and the principles that should underpin the assessment of mergers. The MWG co-chairs intend to update the chapter on The Legal Framework for Competition Merger Analysis, last updated in April 2008, to reflect developments in the last years.

Project 7. "Tools and practices for effective and timely management of merger cases" (Led by Competition Commission of Mauritius)

Merger cases are time sensitive and resource intensive calling for their effective and timely management. Indeed, competition authorities around the world try to find tools and means to enhance the management of their merger cases, and in that perspective have developed tools and practices for the effective and timely management of merger cases. Hence, the MWG Co-Chairs intend to launch a new project which will help in identifying the different tools and practices implemented by the various competition agencies and share same amongst all members.

This project aims to create a repository compiling all the tools and best practices which are used by competition agencies to effectively manage merger cases. The project will also include the challenges of these tools and practices when being considered by the agencies.

These tools will then be shared with the ICN members through a report which they can consult to inspire themselves to develop their own tools or adopt existing one to enhance the management of their merger cases. The report can also be used as a benchmark by competition agencies.

The project will be led by the Competition Commission of Mauritius.

Project 8. Investigative Techniques in Merger Review (Led by KT)

The MWG hosted a series of webinars on the topic "Investigative techniques in merger review" in 2024. This will be followed by a summary report to be prepared in 2024.

Topics included: (a) the use of quantitative methods (e.g. survey design and analysis, price pressure, etc.); (b) review of parties' and third parties' internal documents; (c) efficiencies (e.g. assessment, obtaining reliable evidence, etc.).

The aim of the project is to share best practices among the ICN members on investigative techniques used in merger control, and to foster cooperation.

Past Projects

The MWG has pursued work in broad categories: merger evaluation, digital mergers, updating existing work products, notification and review, investigative techniques, analytical frameworks, cooperation, and other policy issues. From year to year, the MWG work focuses on different categories, with the intent to cycle through all aspects of merger enforcement on a regular basis.

For example: in 2016 completed work on remedies analysis, 2017-18 revisions to ICN's Recommended Practices on notification and review, and 2018-2019 comparative study on vertical merger analysis as well as 2019 enforcement cooperation tools.

In 2019-2020 the MWG focused on a comparative survey and report on conglomerate mergers, a comparative survey and report on procedural infringements and a series of global webinars on digital mergers and on sound decision making. In 2020-2021 the MGW worked on a comparative survey and report on joint ventures, a regional webinar series on the impact of COVID-19 to the competition authorities' merger review processes, a webinar series on merger remedies, and the update of the merger notification and procedures template.

Following this previous work in 2021-2022 the MGW organised a series of webinars on ex post merger review, hosted the 2022 ICN Merger Workshop in Brazil, began the update of the ICN Recommended Practices Chapter on Entry and expansion, and started a multi-year comparative survey and report on Control of data, market power, and potential competition in merger reviews. In 2022-2023, the MWG continued working on the update of the ICN Recommended Practices (RP) Chapter on Entry and expansion and the report on Control of data, market power, and potential competition in merger review. The MWG also started the update of the ICN RP with a new chapter on non-horizontal mergers and the project "Digital Mergers" consisting in a series of webinars on the topic "Digital Mergers" followed by webinar notes, and an overall report.

In 2023-2024, the MWG completed the update of the ICN RP Chapter on Entry and Expansion as well as the project on "Digital Mergers". The MWG also held a series of webinars on investigative techniques. The MWG continued working on the update of the ICN RP with two new chapters on non-horizontal mergers (new chapter approved by the Steering group in April 2024) and counterfactual, as well as on the update of the ICN RP Chapters on Unilateral Effects and Coordinated Effects.
